OBSERVATIONS

SAFARI BIKE AFRICA, company registered in Tanzania, with license of Tour Operator TALA N° 665573, understands that the traveler is aware of the effort that can lead to a journey of these characteristics, which is carried out by land for the most part, by roads and roads in many cases in bad conditions, being able to present difficulties and being exposed to suffer setbacks and adversities, such as: low food variety, climatology, breakdowns and various difficult situations, where physical and moral fatigue and discouragement can be present, both during the travel road, walking, cycling, travel by canoe or other means, as well as during your own development of the general activity. SAFARI BIKE AFRICA understands that the traveler is willing to take it as part of the content of this adventure trip.

SAFARI BIKE AFRICA understands that the traveler is aware that he / she participates voluntarily in a trip to a foreign country or countries with characteristics different from their country of origin, visiting remote, remote, exotic and / or tropical areas with structure and organization, to all levels, different from what you may be accustomed to in your normal life and where diseases endemic to the country of origin of the traveler for which prophylactic, under the responsibility of the traveler himself.

SAFARI BIKE AFRICA understands that the traveler voluntarily accepts all possible risks and adverse circumstances on the basis of all of the foregoing, exempting SAFARI BIKE AFRICA and any of its members or employees of any responsibility, except for the established in the laws, for any fact or circumstance that occurs during the trip or expedition by the characteristics of the areas where it develops, as situations escape the control of the organization of the trip.

SAFARI BIKE AFRICA understands that the traveler knows the general and particular conditions of the travel expedition program and meets all the requirements required for the trip.

If your entry into the country is denied due to lack of the required requirements, or a defect in the passport, or for not carrying it, the organizing agency declines all responsibility for the consequences arising from events of this or similar nature, on the account of the passenger that the conditions set out for cancellation or voluntary dissent of services.

In the event that it is necessary to send documentation for postal or courier services, the in no case will the organizing agency incur any liability for loss or delay to submit these documents. due to the permanent variation of the legal requirements to visit certain countries, means of transport, tariffs etc., the agency acts as a mere informant, being the responsibility of the travelers reconfirm the required documentation with the different consular representations, sanitary, administrative authorities, transporters, etc

TERMS

Terms and Conditions:

"The client, once the reservation is formalized, may desist from the services requested or contracted entitled to the repayment of the amounts paid up to the moment, but should be to indemnify SAFARI BIKE AFRICA, without any exception, due to the costs of the the management and booking of the trip. Our management expenses can be reviewed as long as the cancellation is due to force majeure, understood as such circumstances outside of whom invoke them, abnormal or unforeseeable, whose consequences could not have been avoided, despite acted with due diligence.

It can happen that some of the services loose or the trip combined is subject to conditions special economic hiring, such as freight of aircraft, ships, special tariffs, etc. as is the case of the truck routes for

Africa. These special conditions are accepted in the amount correspond at any moment with the signing of this contract.

The present general conditions will be incorporated, signed by the contracting parties, as part integral part of the same, to the particular conditions that are agreed in the contract or that appear in the documentation of the travel provided simultaneously with the signing of the contract.

The General Conditions that regulate this trip are those that reflects this contract; the client declares to know and accept the regulations that govern this contract and accepts it in its entirety.

CLAUSES

FIRST: The undersigned, hereafter called client hires the trip called SAFARI BIKE AFRICA detailed on this sheet, available to customers who wish in all agencies together with the accompanying information and accompanying modifications.

SECOND: The realization of this trip is conditioned by registration at the same minimal of 2 people. If this minimum is not reached, the organizing agency will be obliged to inform the client directly, or through the selling agency, cancellation of the trip in a term not less than 15 days before departure

THIRD: The organizing agency provides the client with the perception in the terms set out in the clause five, the following services:

- Transport: according to technical specifications.
- Accommodation: according to technical specifications.
- Itinerary: according to the technical file.
- Other services: travel assistance insurance, and other services according to the technical specifications.

FOURTH: The luggage and other personal belongings of the user are not subject to the travel contract combined. In terms of land transport and for all purposes, it is understood that whatever the part of the vehicle in which they are placed and which is transported on account and risk of the user, without the Organizing Agency being obliged to respond to the loss, theft, or damage it may suffer during the journey for any reason, including hotel / airport transfers or vice versa, when they exist it is recommended that users be present in all handling of loading and unloading of the luggage.

In the case of air, sea or inland waterway transport of luggage, the conditions of the regulated by IATA. In the event of suffering damage or loss it is recommended present, at the time, the timely claim in the transport Company, unless it is specified within the brochure the contracting of travel insurance that contemplates it.

FIFTH: The price of this package has been calculated in Euros based on rates transport costs, fuel cost, infrastructure cost, cost of national parks, land services at destination, taxes, taxes, etc. The price of some of these services, quoted in dollars, has been converted to Euros based on the euro / dollar exchange rate 1 € = 1.2US \$. Any variation of more than 12% in the aforementioned exchange rate may result in a price revision end of the trip, both upward and downward. Under no circumstances will it be revised upwards in the 20 days prior to the date of departure of the trip, with respect to the requests already made.

SIXTH: The customer accepts the possible revision of prices of travel if there is variation in the assumptions of clause 4. The price can only be revised up to 20 days before departure

SEVENTH: The price of this trip is for € 3,600, taxes included, per traveler. There is supplement of € 290 on departures from July 1 to August 21 inclusive. The payment of the total price of the present shall be made at the selling agency for the delivery of the travel, to the signature of this contract

EIGHTH: In case of cancellation of the trip by the client, it accepts the payment of expenses cancellation and cancellation on the total of the trip contracted, including the local payment in destination against invoice where applicable, under these conditions:

Administrative expenses plus cancellation costs, if any in any case and determined by the organizing agency, due to the strict conditions of contracting of the services that compose this trip to SAFARI BIKE AFRICA

RESERVE REQUIREMENTS:

Reservations made more than 60 days prior to departure date, 40% deposit of the price of the trip to the reservation and the remaining 60% must be paid 45 days before the date of output.

For reservations made less than 45 days prior to departure date, full payment of the trip

SPECIAL CONDITIONS CANCELLATION

In the event of cancellation, the customer will lose:

- Fixed cancellation charges of € 100 per person.
- Up to 60 days before the date.- 40% deposit made.
- From 59 to 31 days before departure.- 50% of the price of the trip.
- From 30 to 0 days before departure.- 100% of the total price of the trip (without Local rates).

Not to stand out, the customer must pay the full amount of the trip.
